PROGRAM DESCRIPTION

The Olami DC Internship program is a seven-week summer session combining an outstanding position in your field of interest with robust Jewish learning and living experiences.

Students live together in housing based in Silver Spring, MD, an active Jewish community outside of Washington, DC. Internships are located either in DC proper, in the surrounding suburbs or, in some instances, a bit north in the Baltimore metro area.

In addition to the routine work schedule, interns participate in several weekly Jewish learning sessions, and 4-5 full Shabbat programs, both in Silver Spring and in other locations. A one-week Jewish immersion retreat takes place immediately prior to the six-week internship period.

TERMS AND CONDITIONS

PROGRAM PAYMENT & DEPOSIT

- The cost of the program is \$699.
 - A \$299 payment is due up front, before we begin the process of internship placement. This allows us to spend the requisite time with your profile.
 - The balance of \$400 is due within seven (7) days of your acceptance to a position.

- Given the amount of time spent on your individual placement, the initial \$299 deposit is NON-refundable as long as Olami offers you a "reasonable" internship option within 90 days of your payment date. The remaining \$400, paid after placement, is non-refundable as well.
 - "Reasonable" in this context means that we have connected you to one or more internship options within your general area of interest, as expressed in your written application and/or interview.
- In addition, we collect a \$300 deposit, returned at the successful completion of the program. Failure to participate in any aspect of the program, without express permission from program staff, may result in the forfeiture of this deposit, fully or in part.

INCLUDED IN \$699 PROGRAM PAYMENT

- Lodging in Silver Spring throughout the duration of the program.
- Dinner most evenings (there may be some exceptions when you will be asked to provide for yourself).
- Light breakfast food and supplies (drinks, etc.) available in your house.
- Programming/activity fees.

- Transportation to/from the Silver Spring area to/from your home/point of origin/return
- Transportation to/from your place of employment
- Lunch on a daily basis

ADDITIONAL DEPOSIT INFORMATION - TO BE PAID 30 DAYS BEFORE THE PROGRAM COMMENCES

- Your \$300 Deposit will be refunded within 60 days of program completion, provided you have satisfied all program requirements, which include:
 - Attendance at our pre-program Jewish exploration retreat
 - Attendance at all Jewish learning sessions.
 - Each participant is granted one excused absence, after which the deposit will be forfeited unless s/he takes responsibility to make up the session privately. The onus to do so is on the participant.
 - Attendance at all mandatory Shabbat programming (not including the “off” weekends).
 - The only exceptions to this rule are for true emergencies, including a death in the immediate family, or a pre-approved need as cleared with staff. In the event of a non-emergency absence, you may be required to make up the Shabbat on an otherwise unscheduled weekend.
